## 2023 Stallion Breeding Service Contract

This contract is entered into and is between the undersigned known as "STALLION OWNER" and the undersigned "MARE OWNER". This contract sets forth the rights and responsibilities of the parties for the breeding season 2023.

The stallion providing breeding services under this contract is: SD BLUE: Gypsy Stallion- Blue Roan Ee, Rr, pssm1 neg.

The mare to be bred is:

1. MARE OWNER shall pay the sum of \$2,000 as a breeding fee: \$500.00 of which is payable at the time of the execution of this contract as a nonrefundable booking fee. The balance of \$1,500.00 is due prior to collection.

### **BREEDING SERVICES:**

**The collection and/or shipment fees are NOT included in the above listed stud fee. This fee is determined by the collection facility and varies depending on shipping method. MARE OWNER can estimate these costs to range approximately \$450- \$550 each time the service is rendered.**

2. It is the MARE OWNER'S responsibility to inform the STALLION OWNER at least 24 hours prior to needing a shipment of semen. Collections are made on Mondays, Wednesdays, and Fridays only. Cancellation must be made by 8:00 AM EST on shipping day. All semen will be sent from the Stallion Owner's collection facility via FedEx overnight or counter to counter (recommended) same day delivery.

3. The STALLION OWNER will not be held responsible if the mare fails to settle for any reason. The service may be repeated, with vet verification, until the mare settles. Additional shipping and collection fees will be the responsibility of the Mare Owner. Mare must be inseminated on the date of delivery by a licensed veterinarian. The semen may be used for the designated mare only.

### **MARE'S CONDITION AND OWNERSHIP:**

4. The MARE OWNER represents and warrants that the mare is in sound breeding condition and free from any disease or infection. MARE OWNER represents and warrants that MARE OWNER is the registered owner of the mare and shall upon request provide STALLION OWNER with a complete copy of the mare's registration papers. MARE OWNER represents and warrants that he/she has the authority to enter into this agreement.

### **SUBSTITUTION OR ASSIGNMENT:**

5. Neither party may assign or transfer this agreement without the prior written consent of the other party. In the event Stallion becomes unavailable for breeding due to stallion's death, injury, illness, or infertility, the STALLION OWNER shall notify MARE OWNER and MARE OWNER will be refunded.

**LIVE FOAL GUARANTEE**

5. The term "live foal" shall mean a foal that will stand and nurse without assistance. In the event that the mare does not deliver a live foal during the breeding season, the MARE OWNER shall be entitled to one additional re-breed to the same stallion subject to the provisions of this agreement.

6. The live foal guarantee however shall be void and the STALLION OWNER released from any liability or obligation in the event that: a.) The mare is sold by the MARE OWNER prior to foaling unless STALLION OWNER agrees in writing to continue the live foal guarantee. b.) MARE OWNER breaches any representations or warranties as set forth in this agreement. c.) Mare's failure to give birth to a live foal is due to the actions or inactions of the MARE OWNER. d.) The booster rhinopneumonitis vaccinations are not administered by the MARE OWNER as the mare progresses through pregnancy. e.) The MARE OWNER does not provide proper notification to STALLION OWNER within one week of the date the mare aborts her foal or delivers a stillborn foal. "Proper Notification" shall be defined as written certification by a licensed veterinarian within one week of the date the mare aborted or produced a non-viable foal along with the MARE OWNER'S certification that the abortion or death did not result from any act or omission of the MARE OWNER. If mare is unable to conceive or carry a foal to term, another approved mare may be used.

**BREEDER'S CERTIFICATE:**

A breeder's certificate will be issued to the MARE OWNER after all fees and expenses have been paid in full and upon notification of the birth of a live foal.
